

## TERMS & CONDITIONS

By submitting the registration form, delegates confirm agreement with the terms and conditions of the 25th Insurance & Reinsurance Meeting.

### Registration

- Participation in the 25th Insurance & Reinsurance Meeting requires the completion of the registration field (step 1 of the registration form) and is confirmed upon payment of the full amount.
- Registration will not be confirmed until the completed registration form and payment is received and processed by the Registration Office.

### Registration fee

- Participant Fee: €350  
Accompanying Guest Fee: €120
- Registration fee is detached from accommodation & transfer cost.
- Delegates can choose accommodation and book boat tickets to/from Hydra via the registration platform on a first come – first served basis OR register, settle the registration fee, and then make their own arrangements for accommodation and transfer.
- Total cost including registration fee and other bookings (accommodation and transfer) will be automatically calculated in the platform.

### Payment

- Payment must be made within 5 working days of the registration date.
- Upon payment receipt by the registration office, the registration process will be automatically completed, and you will receive a confirmation e-mail.
- If payment is not concluded within 5 working days of the registration date, all bookings will be automatically cancelled. Those who wish to participate must repeat the registration process and book accommodation and transfer based on availability.

If the Registration office has not received payment or bank transfer receipt within this period, all bookings will be automatically cancelled. Those who wish to participate must repeat the registration process and book accommodation and transfer based on availability.

### Program

- The program of the Meeting is announced at [www.eaee.gr](http://www.eaee.gr) and at web app. The program is subjected to modifications. Any change will be announced at [www.eaee.gr](http://www.eaee.gr) and web app.

### Accommodation

- Accommodation is not part of the participation fee. Participants can book accommodation on extra cost via the 25th Insurance & Reinsurance Meeting registration platform OR make their own arrangements (provided they settle the registration fee). The rooms available on the registration platform are pre booked and pre-paid by the Organizer.
- Please note that hotel / accommodation availability in the platform may vary as a result of cancellations or new reservations.
- All rooms available at the registration platform are offered for 2 nights (In: May, 21st | Out: May 23rd, 2025).
- Stay tax and all applicable taxes are included in the hotel cost.

### Transfer

- Transfer is not part of the participation fee. Participants can enter the registration platform and book and pay a boat ticket on extra cost.
- The boat tickets available on the registration platform are pre booked by the Organizer at a preferential group rate and cannot be changed once issued.
- The boat trip duration is up to 2 hours depending on the itinerary.

### Cancellation Policy

- Cancellations and refund requests must be submitted in writing to the Organizer ([hydra@eaee.gr](mailto:hydra@eaee.gr)).
- Upon cancellation request hotel reservation and boat ticket reservation are automatically cancelled.
- Cancellation terms apply to all services chosen by delegates to pay via the registration platform (e.g. registration fee, accommodation, boat tickets) as follows:  
Cancellations before or by **April 30th, 2025** will be refunded by 50%.  
Cancellations from **May 1st to May 10th, 2025** will be refunded by 30%.  
Thereafter, we regret that no refund can be made.
- Refunds will be effected after the event and within 1 month time via bank transfer or to your credit card.
